

Author's Submission Agreement

By submitting a copy of my article (the "Article"), I (the "Author") hereby agree with Radio Amateurs of Canada Inc. ("RAC") to the following terms and conditions relating to the Article:

- 1. I represent and warrant that:
 - a. the Article is my own work;
 - b. if some part of the Article is not my own work, for that portion of the Article, I have obtained the appropriate rights to provide RAC with the rights it requires in this agreement;
 - c. to the best of my knowledge, the Article contains information which is correct at the time of submission;
 - d. except as I have advised in writing, the Article has not been submitted by me for publication or been published in any other media; and
 - e. the biographical information that I have provided RAC is correct and contains information about me that I agree can be published.
- 2. RAC shall insert appropriate disclaimers in its publications to disclaim liability of the author's Article for costs, loss, damage or injury that may arise through the use of the information in the Article.
- 3. I shall retain ownership of the copyright in the Article. I shall continue to have the following moral rights in the Article:
 - a. The right to be considered to be the author of the Article; and
 - b. The right to prevent changes to the Article, except as agreed between me and RAC, that would be detrimental to my reputation.
- 4. RAC shall have the right, without payment to me, to:
 - a. Decide whether or not RAC wishes to publish the Article in full or in part or parts in any media including on RAC's website, in RAC's publications including *The Canadian Amateur*, or in any other publication or media owned, published or controlled by RAC;
 - b. Edit the Article for possible publication in any media owned, published or controlled by RAC in accordance with RAC's editing practices as those may exist from time-to-time. Where such editing may materially affect the content of the article, I shall be advised of the intended edits and must agree with them prior to publication. In such editing, I shall cooperate and respond with RAC's editing practices including response times;
 - c. Publish the Article as edited (such edits being agreed to by me if they materially affect the content of the article) in any media owned, published or controlled by RAC in accordance with RAC's publishing practices as those may exist from time-to-time; and
 - d. Re-publish the Article as it may be further edited (such edits being agreed to by me if they materially affect the content of the article) in any media owned, published or controlled by RAC in accordance with RAC's publishing practices as those may exist from time-to-time.

For greater certainty, and without limitation, RAC shall have no obligation to publish the Article in any form but, if it does, it may publish the Article as it sees fit one or more times and for any fee or in any form of controlled distribution that RAC, in its sole discretion, decides.

- 5. In the event that RAC does publish the Article in a form as agreed herein, my consideration for this agreement shall be the publication of the article itself and this shall be a binding contract from the time of my submission of the article. Except as may be expressly agreed with me in writing, I shall not be entitled to any payment for the publication or re-publication of the Article by RAC even if RAC is receiving compensation directly or indirectly for the use of my Article.
- 6. To the extent that RAC suffers any loss or damage as a result of any breaches of my representations and warranties at any time, I shall indemnify and save harmless RAC and its directors, agents and volunteers from any such loss or damage. This clause only applies to my representations and warranties given in clause 1.
- 7. If there is more than one author on the Article, each of us shall be considered to jointly and severally be binding themselves to the terms of this agreement as an Author.
